



Town of Wilkesboro Demonstrations Permit

The Chief of Police for the Town of Wilkesboro in accordance with Chapter 92 of the Wilkesboro Town Code hereby grants a permit for
to conduct or participate in a parade, picket line, or group demonstration in or upon any street, sidewalk, or other public place within the Town of Wilkesboro as follows:

- The name, address and telephone number of the group allowed to parade, picket or form a group demonstration is designated as follows:
- The person in charge of said parade, picket line, or group demonstration on any street, sidewalk, or other public place is:
- Minors under the age of eighteen will or will not be permitted to participate in the stated activity.
- The person in charge of the activity will accompany the parade, picket line, or group demonstration and carry such permit with him/her at that time. Such permit will NOT be valid in the possession of any other person other than the person in charge:
- The starting time for said activity is _____ (time) on the ____ day of _____, 20____.
- The ending time for said activity is _____ (time) on the ____ day of _____, 20____.
- The route of said activity will be as follows:
- The speed of travel of such activity will be as follows:
- The space between persons or vehicles in the parade, picket line, or group demonstration is estimated to be as follows:
- The portion of areas of streets, sidewalks, or other public places to be used will be as follows:
- The above described activity in the areas and during the times as set forth above shall not infringe upon the free movement of pedestrians or vehicular traffic or the health, safety, and property rights of the general public or the participants.

- The above proposed activity shall not constitute a clear and present danger to the public health or safety or hinder the orderly movement of pedestrian or vehicular traffic on the streets, sidewalks, or public places in the Town of Wilkesboro.
- No one involved in the permitted activity as granted in this permit shall carry any firearm or weapon, including but not limited to blackjacks, nightsticks, flashlights, or any other article which might constitute a deadly weapon, not to take or keep any dogs or vicious animals, whether leashed or unleashed, during said activity as permitted herein or carry or display any flag of any foreign state or any foreign political party or other organization, which engaged in hostilities against the armed forces of the United States during the activity permitted herein.
- The activities as permitted shall not interfere with the right of property owners in the area to enjoy peaceful and lawful occupancy and use of their property.
- If a picket or picket line is the subject of this permit, the following additional rules and regulations apply:
 - a. picketing may be conducted only on the sidewalks reserved for pedestrian movement and may not be conducted on any portion of a street used primarily for vehicular traffic;
 - b. not more than ten pickets promoting the same objective shall be permitted to use either of the two sidewalks within a single block at any one time.;
 - c. pickets may carry written or printed signs not exceeding two feet in width by two feet in length promoting the objective of the picket, however the words cannot be derogatory or defamatory or profane in nature.
 - d. pickets must march in single file, not abreast and not closer together than fifteen feet except in passing one another;
 - e. pickets will not be allowed to walk more than five feet from the curb line and shall be in continuous motion;
 - f. if pickets promoting different objectives desire to use the same sidewalk for picketing and such would result in the presence of more than ten pickets thereon, the Chief of Police shall allot time to each group of pickets for the use of such sidewalk on an equitable basis.
- Violation of any of the provisions of this permit will void this permit. The Chief of Police or the highest ranking police officer, in the absence of the Chief, shall have the authority to void and revoke this permit for any violation of said permit.

This permit is hereby granted by the Chief of Police of the Town of Wilkesboro subject to all condition as set forth and above at _____ (time) this the _____ day of _____, 20____.
